Marine theft risk

Marine assets, even those believed secure, are vulnerable to theft. We are often taught not to gamble, but many gamble daily, allowing valued assets to be stolen without the means of instigating a safe and quick recovery.

When it comes to the recovery of stolen marine assets, there is no number plate recognition system, compulsory insurance or registration database to aid investigation. With little else to help the police, marine theft recovery and prosecution rates remain low.

It is therefore not much of a surprise to find that marine theft is now showing signs of being on the increase. For criminals, targeting the marine user represents an easier choice, poor if any security systems from marine manufactures are easily overcome, combined with, little if any risk of ever being caught.

Top of the marine theft 'Most Wanted List'outboard engines, closely followed by PWC and RIB's, with reports on these alone, expected soon to break two thousand five hundred on www.stolenboats.org.uk

The true cost of marine crime is unknown, with many marine crimes going unreported. The use of locks, wheel clamps, electronic ID tags and alarms can act as a deterrent but will do little to protect against a determined thief, and do not provide directly any means of locating the asset.

Offshore Race Tracking

There are considerable advantages with having the Mtrack Boatwatch portable GPS tracking unit placed into competitor's vessels before the start of a race. The detailed GPS data for each vessel can be viewed in real time by safety officers to help them identify vessels showing early signs of distress and by race officials to check rule conformance at the race start, turning points, exclusion zones and finish line.



Regular GPS race status reports can additionally be made available to the much larger viewing public to watch the race online. This could provide additional sponsorship opportunities for race sponsors, Automatics with our partners have already successfully completed the race tracking services for RI10 (Round Ireland 2010) and currently progressing trials for RB12 (Round Britain 2012).

Installation

Finding Operations

A radio find operation is required when assets are hidden from GPS view or when we are only using the GSM and RF location technology. Automatics will deploy the closest available finding agent. All agents are preferred, highly trained and professional staff selected specifically for this role. Agents will operate within the guidelines of the law in all countries of recovery, once an asset is positively located we liaise with the relevant authority to aid final recovery and we manage this process on the behalf of clients.
